# FELSTED PARISH COUNCIL

### Minutes of the 1079th meeting held on 1 July 2020 at 6:00 pm using the Zoom online platform

Present: Councillors Graham Harvey (Chairman), Andy Bennett, Alec Fox, Richard Freeman, Penny Learmonth, Frances Marshall, Roy Ramm, Richard Silcock (entered during Item 20/112.2) and Joyce Stoddart. County Councillor Simon Walsh (left after Item 20/112.2) and District Councillor John Evans were also present along with 3 members of the public. In attendance: The Clerk, the Assistant Clerk and the RFO.

# 20/107 Apologies for Absence and Declarations of Interest

Apologies had been received from Councillors Peter Rose and John Moore, District Councillor Sandi Merifield and Youth Representative Elliott Smith. There were no declarations of interest.

### 20/108 Public Forum

**108.1 Replacement litter bin near church archway -** The Clerk confirmed that a waste bin had been ordered for near the church archway. There was a supply issue but it was on an order list for when becomes available.

**108.2 Churchyard wall -** The clerk confirmed that the preferred layout has been agreed for the churchyard wall. Final plans were awaited in order to apply for planning permission. David Dempsey offered to help update the plans.

**108.3 Byway 101** - A member of the public addressed the council re Byway 101 see Agenda Item 20/118 below.

**108.4 Zoom meetings -** The council were complimented on using the new zoom on-line meeting platform. Cllr Graham Harvey said it was unlikely that the PC would have any physical meetings this year. All council business is proceeding as usual with both full PC and Committee meetings taking place successfully on-line.

**108.5 Councillors e-mail addresses on PC website -** It was suggested that it would be useful to have councillors individual email addresses on the council website. Cllr Andy Bennett will put them on the website together with a recommendation that the Clerk be copied into any email sent to individual councillors in case the councillor happens to be away.

# Matters arising from the June Council meeting

**111.1 Community Initiative Fund (Item 20/95.1)** - The Asst Clerk confirmed that following submission of the pre-application form to EALC for funding to provide additional play equipment at the Willows Green play area, Council had received permission from EALC to submit a full grant application. Asst Clerk had met with 3 play equipment companies and was awaiting quotes. If received it will need to be match funded. The Clerk confirmed that £6000 was ring fenced in the budget for this project. It was proposed by Cllr Francis Marshall, seconded by Cllr Alec Fox and unanimously agreed that an application be made to the CIF for £6000 giving a total budget of £12000 for redevelopment of Willows Green play area. Asst Clerk confirmed that the application needs to be submitted by 16<sup>th</sup> August.

**111.2 Churchyard Wildlife Area (Item 20/95.3)** – JCM Services had confirmed that a pathway had been created through the Wildlife Area to enable family members to tend a grave.

**111.3** Felsted Memorial Hall (Item 20/96.3) – The request for a donation towards the upgrading of the toilets was discussed at the Finance Committee meeting on Monday 29<sup>th</sup> June. It was agreed that a donation of £500 would be made.

**111.4 Playing field hedges -** The Clerk confirmed that JCM had cut all the hedges around the play area on the main playing field.

# 20/112 District and County Councillor Reports

**112.1 District Councillor's Report** – Cllr Evans was thanked for his ongoing updates on the Local Plans. Cllr Evans said that as much participation as possible from all Parish and Town Councils throughout the district was encouraged.

UDC are considering reducing the numbers of people who go into the office on a more permanent basis. No decision has yet been taken. A view will be taken on it over the next few months. Much needed revenue could be derived from alternative use of the space.

**112.2 County Councillor's Report** – Members noted that County Cllr Simon Walsh had submitted a Report for July 2020 which included items on the re-opening of the remaining 6 recycling centres. Existing centres had been extremely busy. Cllr Walsh requested that where possible residents wait before going to the recycling centres to ease the pressure. Libraries are scheduled to re-open with the bigger ones in the first phase. This will enable the registrations of births to recommence.

The Government has asked ECC to set up a local track and trace system and this has been done. Cllr Walsh said we are beginning to move through the recovery phase but it would still be a long process. Should further localised lockdowns become necessary a special committee had been set up to manage the situation.

Possible S106 development monies could be available from prior developments in the parish to help with local projects. Cllr Walsh also has a fund which he is able to distribute to local good causes.

He warned that travellers are moving in the area and recommended securing any open spaces. Cllr Simon Walsh was asked for an update re flooding at Milch Hill and the road at Mole Hill Green at the end of Hollow Road. Cllr Walsh agreed to chase again and said if necessary he would ask for a meeting with the cabinet member responsible. Cllr Richard Freeman requested that Cllr Simon Walsh add the flooding of Causeway End pond/ditch to the meeting with the cabinet member as this is an on-going problem impacting an elderly couple.

# 20/113 Correspondence

Members noted the Correspondence received (see page 6) including the following:

**113.1 UDC Hub Meeting –** This is a new initiative. Cllr Harvey has asked to join the next meeting.

**113.2 ECC** - **Salt Bag Partnership Scheme** – They are offering salt supplies again this year although they are not sure if they can source them. It was confirmed that Felsted has plenty of salt and will not need to order more.

113.3 Footpath 48 – Replacement of the 'wrong footbridge' – Members noted that following ECC Highways recently replacing the wrong footbridge on FP48 between Jollyboys Lane North and Bannister Green they have now scheduled to replace the correct bridge on 29<sup>th</sup> July.
113.4 Felsted P3 Footpath Group – ECC have provided them with a second hand brushcutter. It is in for service. Under the terms of the agreement the Parish Council pay for the service and any parts replaced and then re-claim from ECC.

**113.5 Trimming of Playing Field Hedge** - Request from resident requesting that the playing field hedge behind their property be trimmed. In past years some residents have asked for the hedge behind their property to be cut back, whereas others ask for theirs not to be cut back. The Parish Council will respect residents wishes. The Clerk will therefore check with the other residents and ask if they would also like their hedge trimmed. JCM Services will then be asked for a price.

**113.6 JS Wright and Son Willow Plantation** – They are experiencing incursions onto their plantation in Station Road (adjacent to River Chelmer). This is on the Flitch Green/Felsted border. Wrights have written to Flitch Green Parish Council and also to Felsted Parish Council. They request that Felsted PC publicise that there is NO Public Right of Way across the plantation. This will be posted onto the PC website. The Clerk will confirm to Wrights that this has been done.

# 20/114 Finance

**114.1 Payments –** The list of payments on page 7 were approved.

**114.2 Internet Banking** – The RFO is investigating the setting up of internet banking for the Parish Council.

**114.3 Receipts** – Members noted that receipts for the year so far were  $\pounds$ 38500 for the first half of the precept,  $\pounds$ 100 for an advertisement in Felsted Focus and  $\pounds$ 31 for allotment rents.

**114.4 Confirmation of appointment of internal auditor for 2020-21** – The PC confirmed the re-appointment of Maurice Howard to carry out the Internal Audit for the year 2020-21

**114.5 Fill vacant seats on Finance Committee -** Cllr John Moore has stepped down as both Chair and a member of the Finance Committee. Cllrs Penny Learmonth and Roy Ramm both agreed to join the Finance Committee. Cllr Graham Harvey will take over as Chair.

The PC recorded their thanks to Cllr John Moore for all the work he has done as Chair of the Finance Committee for the past 10 years.

**114.6 Consideration of the Internal Audit Report for 2019-20** – Members noted the Internal Audit Report which had been submitted by Maurice Howard.

**114.7 Approval of the 2019-20 Audit Annual Governance Statement -** The Finance Committee had studied the accounts and Audit Return in detail at their meeting on 29th June

2020. It was unanimously agreed to approve the Annual Governance Statement.

This document will be physically signed by the Clerk and Chairman prior to submission to the External Auditors

**114.8 Approval of the 2019-20 Audit Accounting Statements and Audit Return** – It was unanimously agreed to approve these documents. The documents will be physically signed by the Chairman and the Clerk/RFO prior to submission to the External Auditors.

# 20/115 **Coronavirus situation – Re-opening play areas**

Cllr Graham Harvey will join an online EALC webinar on Friday 3<sup>rd</sup> July and circulate any advice received to Councillors. If appropriate a decision will be made via e-mail.

# 20/116 Playing Fields

**116.1 Quote for Playbark edging works/Playbark top up (supply and spread)** - Members considered a revised quotation to replace the wooden edging around the playbark section of the children's play area. It was proposed by Cllr Alec Fox, seconded by Cllr Andy Bennett and unanimously agreed to accept the quotation from local builder, Glen Mixture, to replace the rotten wooden edging at a cost of £2700.

Members considered quotes received for 30 cubic metres of Playbark. It was proposed by Cllr Roy Ramm, seconded by Cllr Richard Freeman and unanimously agreed to accept a quote from Giffords for £1250 for the supply and delivery of the bark, and to accept a quote from JCM services for £670 to renovate, level and spread the bark.

**116.2 Bannister Green play area fence** – Members considered various options contained in a report pre circulated by the Asst Clerk. Option B a wooden 'built on site' picket fence for £2890 was proposed by Cllr Roy Ramm and seconded by Cllr Richard Freeman. This was approved unanimously.

**116.3 2020 Play equipment inspection report** – Members noted that the 2020 Playground Inspection Report had been received. No items were categorised as high risk or requiring urgent attention. The Asst Clerk would meet with the Village Attendant to schedule in some minor cleaning and repair works. It was agreed that due to decay the picnic table at Bannister Green would be removed.

**116.4 Willows Green play area problem (consider temporary removal of goal posts)** – The goal post is unstable and needs attention. Cllrs Graham Harvey and Alec Fox would meet on site to assess the problem and arrange for the goalpost to be removed and refurbished by AJB Engineering. It will then be re-installed.

Some antisocial behaviour has been occurring at the play area. This has been reported to Uttlesford's Community Safety Team who deal with low level anti-social behaviour problems.

# 20/117 Allotment site fencing, gates and notices

The Village Attendant had indicated that labour cost would be in the region of £250-300 to install a 4 foot high, heavy duty galvanised chain link fence at the top end of the allotments. The materials (fencing and posts) would be sourced from Janus Timber Company at a cost of approximately £500 and a gate at the Mill Road entrance to the allotments would cost an additional £188 plus posts. The whole project would therefore cost in the region of £1000. A padlock would be put on the Mill Road gate enabling allotment holders to enter. This was proposed by Cllr Alec Fox, seconded by Cllr Francis Marshall and agreed unanimously.

# 20/118 Byway 101 at Willows Green – Stopping Up Order for section adjacent to 16 Evelyn Road

Members noted that this matter had been discussed extensively in Spring 2019 and the Council had agreed to withdraw its previous objection to the application. It was proposed by Cllr Richard Freeman, seconded by Cllr Frances Marshall and unanimously agreed to make no further comment on the application (to support or object) and to leave the decision to the Statutory process.

# 20/119 Chairman's Matters

**New ways of working –** The Chairman reported that the meetings are going smoothly with all Councillors being fully briefed and well prepared before the meetings. Both full council meetings and committee meetings are successfully running on-line. Joining information is well advertised enabling members of the public access to meetings if they wish.

# 20/120 Clerk's Matters

**120.1 Vacancy re public toilets and car park** – The Clerk had advertised this vacancy in Felsted Focus and on the notice boards but there had been no applications received to date. **120.2 Assets of Community Value –**Asst Clerk confirmed that the 5 expiring Assets of Community Value (Allotments, Bannister Green, Ravens Crescent play area, Willows Green play area and the main playing field) had been re applied for and go to UDC Committee for a decision on 14<sup>th</sup> July.

**120.3 Art competition 2020 –** Cllr Richard Freeman reported that entries were being submitted but so far numbers were down on previous years. The competition had been advertised in three issues of Felsted Focus. Cllrs Graham Harvey and Frances Marshall will judge the competition after the closing date of 10 July. This year the competition has been opened up to children of the entire parish, which has been appreciated by residents living in Willows Green and surrounding areas.

**120.4 Churchyard Wildlife Area Policy review** – The Churchyard Working Group will hold a review as to the size/existence/location of the Churchyard Wildlife Area. This will be put on the September agenda. Cllr Penny Learmonth will prepare an article for the Felsted Focus to inform residents as to the intentions/purpose of the wildlife area.
